Hello Der,

Me and Hector went out to the property of 787 Howell St N., this morning but No one was there. I had placed "Notice Order to Vacate" on the property (front door) for Monday, February 2, 2026.

I received a call from the tenant/family member - Scarlett Rose who is residing at the property which the property is registered to Florence Cherry Kimmel. Scarlett just stated they are family member. The two phone number that Scarlett Rose contacted me on and left on the voicemail are 651-317-9110 or 352-752-0775. This property is a tenant occupied.

There is a 500lb propane tank at the rear yard with the line exposed on the ground running from the tank to the house, generator noise was coming from an enclosed metal shed in the rear yard with multiple extension cords running into the house from the rear window. There is no permit pull for propane tank or etc.

Confirmed with Xcel (1/28/2026) that there is no electric or gas to the home since 5/28/2025. Water (SPRWS 1/28/2026) confirmed there is still active service and meter is active on their end. Ramsey County Property Tax/Records confirmed that the registered PO is Florence Cherry Kimmel.
