**Location:** 1340- 1342 Thomas Avenue Back Patio Area

**Noise Source:** Andrew Thoreen of Groundswell has requested a sound level variance, at a requested sound level limit of 50-75 dBA at no specified distance, in order to present live bands with speakers from 6:00 p.m. until 10:00 p.m., with a pre-event sound check from 1:00 p.m. until 5:00 p.m. on August 20, 2016 at 1340-1342 Thomas Avenue. The Department of Safety and Inspections (DSI ) recommends the following conditions: 1) Variance will be for live bands with speakers from 6:00 p.m. to 10:00 p.m., with a pre-event sound check from 1:00 p.m. until 5:00 p.m. on Saturday, August 20, 2016. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 75 dBA at 50 feet from the noise source from 6:00 p.m. until 10:00 p.m. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 p.m. on Saturday, August 20, 2016.
