NARRATIVE

On 07/08/2020 at 2116 hours, Squad 363 (P. Chang/ C. Leon) was dispatched to 1862 E Ivy Ave on a Burglary. The call comments stated the caller at 1858 E Ivy Ave walked by her neighbor's house and saw that the porch window was open and the lights were on. The caller stated no one should be inside the house.

When we arrived, we observed the front porch's window on the right (west) side of the front entrance door was propped open. We walked to the back of the house and we observed the rear entrance door opened and unsecured. The garage door was also opened and unsecured. We then checked the rear door and it appeared to be forced open. The dead bolt was broken off of the rear entrance door.

I then went to 1858 E Ivy Ave to speak with the caller who was identified as EVON MARIE SCHLOE (DOB 11/01/1949, H/P 651-739-4026) while Officer C. Leon was staged by the rear entrance door of 1862 E Ivy Ave.

EVON told me the following: 1862 E Ivy Ave was owned by an elderly female around 80 years old named ELAINE. ELAINE is currently staying at a assisting living home and no one should be in 1862 E Ivy Ave. ELAINE would not come to her house at night and if ELAINE comes, her car would be parked in front of the house. EVON said the lights inside 1862 E Ivy Ave had been on for over one hour. She did not check inside the house. EVON does not know ELAINE's full name or phone number. The last time she saw and spoke to ELAINE was about four to five days ago. EVON did not see anyone entering the house or inside the house. She had no suspect information.

Squad 365 (S. Higgins) arrived on scene and was staged at the front of 1862 E Ivy Ave.

I briefed Squad 365, then I went to the rear of the address.

Officer C. Leon and myself, then cleared the house and we did not locate anyone inside the house. It should be noted there were clothing, silverwares, foods, boxes, and many other house items scattered around inside the house.

Squad 302 (Sgt S. Wilson) was briefed of this incident.

We then contacted the DATA Channel in an attempt to get the homeowner's contact information. The DATA Channel provided us the homeowner's name as ELAINE MARIE VALLANT (C/P 651-675-8560). Using RMS, we were able to obtain ELAINE's DOB as 09/09/1951 from prior incidents at her address.

We attempted to call ELAINE via phone call, with negative results.

Officer C. Leon took photos on scene and uploaded them into the Media Vault.

Because the window, front, rear, and garage doors were unable to be locked and secured, we called Board Up crew via DATA Channel to come board up the three doors and the open window.

There was no suspect information. There were no arrests made.

There is no further information at this time.
