I not sure at the time how much time I need. I am trying to locate a contractor who is able to do the repairs. The contractors I have been in touch with (including the three organizations suggested by The City of St. Paul) have full scheduled work for the remainder of this construction season.

I have trimmed back the shrubbery as described by the legislative aide on Sept 13th. I tried to remove the gate; however, I don't have the tools to accomplish that (the fence was constructed to withstand the snow banks from the alley plowing).

Once I am able to hire a contractor to me with an estimate, I will obtain financing. Per Ms. Suong, City of St Paul financing is an option because my home is titled in my trust. The financing from the three organizations is not possible either because my income exceeds there limits.

I will work to correct these issues described by the City of St. Paul. I do ask that the city allow me additional time to correct these issues.
