Dear Property Representative:

A re-inspection was made on your building on June 3, 2021, in response to a complaint. You are hereby notified that the following deficiencies must be corrected prior to re-inspection date.

A reinspection will be made on July 2, 2021 at 11:15 AM.

Failure to comply may result in a criminal citation or the revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

1. Exterior - Back of House - SPLC 34.08 (2) - Provide and maintain the property grade to slope away from the building to minimize the accumulation of water near the building. This work may require a permit(s). Call DSI at (651) 266-8989.-NEW - June 3, 2021 - There is a downspout at the back of the house that is broken.
2. Exterior - Back of Property - SPLC 34.08(5), 34.32(3) - All accessory structures including, but not limited to, detached garages, sheds and fences shall be maintained structurally sound and in good repair. Provide and maintain exterior unprotected surfaces painted or protected from the elements.
The shed at the back of the property is in disrepair with holes and damaged shingles on the top. The fascia board is damaged.
There is a section of the back fence that is damaged, and the wood is rotten.

3. Exterior - Back of Property - SPLC 34.08 (1), 34.32 (1) - All exterior property areas shall be maintained free from any accumulation of refuse, garbage or feces.
NEW – June 3, 2021 - There is garbage and other items being stored in the back shed.
4. Exterior - Front Stairs - SPLC 34.09 (3), 34.33(2) - Repair or replace the unsafe stairways, porch, decks or railings in an approved manner. This work may require a permit(s). Call DSI at (651) 266-8989.-The front concrete stairs has lots of cracks and damages. There are small sections of the stairs that has pieces broken off.
5. Exterior - Guardrails - SPLC 34.09 (3), 34.33(2) - Repair or replace the damaged guardrail in an approved manner. This work may require a permit(s). Call DSI at (651) 266-8989.-Both guardrails at the back of the house are loose and unsecured.
6. Exterior - House - SPLC 34.09 (1)(2), 34.33 (1) - Provide and maintain all exterior walls free from holes and deterioration. All wood exterior unprotected surfaces must be painted or protected from the elements and maintained in a professional manner free from chipped or peeling paint. -There is some chipping and peeling paint on the house.
7. Exterior - Side of House - SPLC 34.12 (2), SPLC 34.36 (1) - Repair and maintain all required and supplied equipment in an operative and safe condition to properly and safely perform their intended function in accordance with the provisions of the applicable code.-
NEW - June 3, 2021- The dryer duct hood on the side house has broken off again.
8. Exterior - Throughout - SPLC 45.03 (7) - Cut and maintain the grass/weeds less than 8 inches tall. -NEW - June 3, 2021
9. Exterior - Window Screens - SPLC 34.09 (4), 34.33 (3) -Provide or repair and maintain the window screen. -NEW - June 3, 2021 - There are window screens with bent and damaged frames and other window screens that are missing.
