WM states that they have not had contact with this property until the service hold request forwarded to them in January 2024. The account previously belonged to Advanced Disposal. WM was able to find an old record of contact with Advanced Disposal on 09-23-2021. The notes from this interaction state, "Owner wants bill in tenants name due to having the [resident] pay it. Changed name at the owner's request." PO was not receiving garbage bills or notices of non-payment because they were being sent to the address of the previous tenant, however, PO was receiving the assessment notices. The garbage bill has gone to assessments for the following: 2023 (all quarters); 2022 (all quarters); 2021 (all quarters); 2020 (Q4- different PO).
