## **NOTICE OF PUBLIC HEARING**

### Human Movement Management - Ugly Sweater Run 2014

TO: West Seventh/Fort Road Federation, CapitolRiver Council District 17, West Side Community Organization

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

#### **Description of Variance:**

**Location:** Harriet Island and Run proceeds West to Intersection of Lilydale Road and South Joy Avenue, 0.54 miles from High Bridge

**Noise Source:** Human Movement Management has requested a sound level variance to provide amplified iPod speaker music at Harriet Island for the Ugly Sweater Run. The variance is requested for the hours of 9:00 to 2:00 p.m. on Saturday, November 29, 2014.

The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 9:00 a.m. to 2:00 p.m. for the Event on Saturday, November 29, 2014. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 2:00 p.m. on the date of the event.
