Terri,

The fence as proposed cannot be built in the ROW regardless of whether or not there is a fence in the ROW across Riverview Avenue at 149 Sidney. The question as to whether or not a mainline sidewalk will be installed is a separate question from the ability of a property owner to use the ROW for private use when the purpose of the ROW is public. noting that the sidewalk between the house and the garage also appears to be in the ROW and that the ROW is currently 60 feet wide.

A few items to note relative to the fence at 149 Sidney:

- Based on my review of GISMO, no encroachment permit exists.
- Based on review of GISMO street level pictures from 2008, the fence did not exist in 2008.
- Based on review of 2014 Google Maps street level photos the fence appears relatively unweathered, i.e. installed within the last year or two.

I have copied Steve Ubl to determine if a permit was issued for constructing the fence at 149 Sidney. If no permit was issued it would seem to me that DSI would be pursuing enforcement actions.




