Dear Nasir Alameri:

The Department of Safety and Inspections will recommend that adverse action be taken against the Taxicab Vehicle license held by Nasir Alameri d/b/a Blue & White Service Corporation for the City of Saint Paul. The basis for the recommendation is based on the following information:

On September 3, 2010, the Department of Safety and Inspections received the Automobile Liability insurance certificate you submitted for the coverage period of September 3, 2010 through September 3, 2011. Upon review of the certificate, it was discovered that your policy had been cancelled as of July 28, 2010. Therefore, there was a lapse in coverage from July 28, 2010 until September 3, 2010.

Based on this information, per Saint Paul Legislative Code §310.05(m) (2) the licensing office will recommend a \$500.00 matrix penalty.

At this time, you have three options on how to proceed:

1. You can pay the recommended \$500.00 matrix penalty. If this is your choice, you should make payment directly to the Department of Safety and Inspections at 375 Jackson Street, Suite 220, St. Paul, Minnesota 55101-1806 no later than **Monday, October 18, 2010**. Information should be directed to the attention of Christine Rozek. A self-addressed envelope is enclosed for your convenience. Payment of the \$500.00 matrix penalty will be considered to be a waiver of the hearing to which you are entitled.


2. If you wish to admit the facts but contest the penalty, you may have a public hearing before the Saint Paul City Council, you will need to send me a letter with a statement admitting the facts and requesting a public hearing. We will need to receive your letter by **Monday, October 18, 2010**. The matter will then be scheduled before the City Council for a public hearing to determine whether to impose the \$500 matrix penalty. You will have an opportunity to appear before the Council and make a statement on your own behalf.

2. If you dispute the above facts, you can request a hearing before an Administrative Law Judge. At that hearing both you and the City will be able to appear and present witnesses, evidence and cross-examine the other's witnesses. The St. Paul City Council will ultimately decide the case. If this is your choice, please advise me no later than **Monday, October 18, 2010**, and I will take the necessary steps to schedule the administrative hearing.

If you have not contacted me by that date, I will assume that you do not contest the imposition of the \$500.00 matrix penalty. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
