## **NOTICE OF PUBLIC HEARING**

### **Sound Level Variance Request 2019 Saint Paul Winter Carnival – Kellogg Mall Park**

Dear Saint Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

#### **Description of Variance:**

**Location:** 62 Kellogg Blvd. E. - Kellogg Mall Park

**Noise Source:** Saint Paul Festival and Heritage Foundation has requested a sound level variance to provide amplified sound for entertainment and talent performances on a stage in Kellogg Mall Park for the 2019 Saint Paul Winter Carnival. The proposed hours of operation for the stage will be:

- a. Thursday, January 24, 2019 from 11:00 a.m. to 10:00 p.m.;
- b. Friday, January 25 and Saturday, January 26, 2019 from 9:00 a.m. to 10:00 p.m.;
- c. Sunday, January 27, 2019 from 9:00 a.m. to 10:00 p.m.;
- d. Monday, January 28 through Wednesday, January 30, 2019 from 11:00 a.m. until 10:00 p.m.;
- e. Thursday, January 31, 2019 from 11:00 a.m. until 10:00 p.m.;
- f. Friday, February 1 and Saturday, February 2, 2019 from 9:00 a.m. until 10:00 p.m.;
- g. Sunday, February 3, 2019 from 9:00 a.m. to 10:00 p.m.;

The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours as indicated above for each specific event date. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured 50 feet from any sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, or similar devices, shall be turned off no later than times indicated above.
