The variance is requested for the hours of 8:00 a.m. to 12:00 p.m. on Saturday, September 19, 2015. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 8:00 a.m. to 12:00 p.m. at Summit Avenue and Ayd Mill Road for the Event on Saturday, September 19, 2015. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any sound source used for amplification and/or speakers. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 12:00 p.m. at Summit Avenue and Ayd Mill Road on the date of the event.
