Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting has been scheduled for **Wednesday, November 17, 2010, at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse.

Enclosed are copies of the proposed resolution and other documents which will be presented to the City Council for their consideration. This is an uncontested matter concerning the fact that on September 7, 2010, you submitted a Certificate of Liquor Liability Insurance with a lapse in coverage from September 16, 2009 through August 20, 2010. This is a violation of Saint Paul Legislative Code § 409.26 (b) (12). This matter has been placed on the public hearing agenda portion of the City Council meeting during which public discussion is allowed. The licensing office will recommend a ten (10) day closure of your establishment.


