Every morning I pull an empty container or two from the back of my truck not from me I don't drink. Call to have crowds broken up nothing happens they do as they please. Cars parked any damn place they feel even in handicapped spots enforcement on this is a joke. 09/23/2019: Tonight (9/22/19) there was yet another shooting at or near Willard's Liquors. Since I moved into my home in November 2017 there have been at least 3 shootings at or near this location. When I drive down Grotto Avenue, almost every time I am forced to stop my vehicle due to bar patrons walking out into the middle of the street or cars stopping to talk to bar patrons. I have reported these incidents to police, but they don't seem to have any effect. I know the city has looked into this bar before, but I think it may be time to seize Willard's liquor license and close this bar. I DO NOT FEEL SAFE DRIVING PAST THIS BAR! Close it down, please.
