Re: Minnesota Vikings Donation

Dear Mike Whaley:

This letter confirms the mutual understanding between Minnesota Vikings Football, LLC (Vikings) and the City of Saint Paul, through its Department of Parks & Recreation (Organization). In connection with the Organization's initiation and operation of a certified NFL Flag League, Vikings agree to donate **fifteen thousand dollars (\$15,000)** to the Organization. Vikings and the Organization agree that the Donation will be used by the Organization solely for the League's participation fees and expenses, and to purchase flag football equipment for the League, and the Organization agrees to provide Vikings semi-annual reports with respect to the Organization's use of the Donation, the status of the League and participation numbers.

The Organization acknowledges and agrees that the League, as well as any activities or programming related to the League, will be conducted entirely at the Organization's risk. Further, each party agrees that it will be responsible for its own acts and or omissions and those of its employees, representatives, and agents in carrying out the terms of this Agreement Letter and the results thereof to the extent authorized by law and shall not be responsible for the acts and/or omissions of the other party and the results thereof. **Counterparts.** The parties may sign this Agreement in counterparts, each of which constitutes an original, but all of which together constitute one instrument.

Electronic Signatures. The parties agree that the electronic signature of a party to this Agreement be valid as an original signature of such party and shall be effective to bind such party to this Agreement. The parties further agree that any document (including this Agreement and any attachments or exhibits to this Agreement) containing, or to which there is affixed, an electronic signature shall be deemed (i) to be "written" or "in writing," (ii) to have been signed and (iii) to constitute a record established and maintained in the ordinary course of business and an original written when printed from electronic files. For purposes hereof, "electronic signature" also means a manually signed original signature that is then transmitted by any electronic means, including without limitation a faxed version of an original signature or an electronically scanned and transmitted version (e.g. via PDF) of an original signature. Any party's failure to produce the original signature of any electronically transmitted signature shall not affect the enforceability of this Agreement.
