03/20/2002 CF 02-217 City Council suspended auto repair garage license for a period of 30 days, said suspension to be stayed for a period of 18 months on the conditions that: 1) license have no violations of the conditions on his license or violations of the Saint Paul Legislative Code which relate to his business during that 18 month period; 2) the fencing and landscaping be installed by 06/15/2002; 3) a fine of \$500 be paid to the Office of LIEP within 30 days of the adoption of this resolution; and 4) license shall explore possibilities for off-street parking arrangements for his employee's vehicles and shall report to the Office of LIEP on his efforts to make such arrangements within 60 days of the adoption of this resolution. 02/11/2002 Notice of Council Hearing from CAO for ALJ on 02/27/2002, 5:30 PM, in the Council Chambers. SCS

01/02/2002 Letter to Neil B. Dieterich, licensee's attorney, from CAO, stating that the most recent settlement to the City from the licensee had been conveyed but the City is not interested in accepting it, but the City see has a counter-offer. The agreement would be that the licensee would admit to the violations of too many cars on the lot from 08/01/2000 to 12/11/2000, having dismantled cars on the lot on 03/14/2001 and 09/13/2001, and not having the landscaping and fencing done. The City would in turn not pursue the violations for outdoor storage from 12/01/2000 and 09/13/2001, nor the allegation of illegal auto body work from 03/14/2001. The recommendation would be for a 30-day suspension of the license, all 30 days to be stayed for a period of 18 months on the condition that licensee: 1) have no violations of the license conditions in that 18-month period; 2) the property be in compliance with all the conditions on the license except the fencing and landscaping within one week from the date of adoption of the resolution; 3) that the landscaping and fencing be completed by 06/15/2002 and that a bond in the amount of the value of said improvements be posted in LIEP within 30 days of the adoption of the resolution; 4) that a fine of \$500 be paid within 30 days of the adoption of the resolution; and 5) that Mr. Jefferson agree to a condition on his license that he will find off-street parking for his employee vehicles within 60 days from the date of the adoption of the resolution.
