NARRATIVE

On 01/13/2017 at 0244 hours we, Squad 213T (OFC M. KEMPE, OFC K. GRUNDHAUSER), were sent to 1328 Rice St. on a report of an audible alarm sounding at the front door entrance of Mini Super La Chiquis.

We arrived on scene and noticed that the front door had been forced open by some type of tool. The dead bolt of the door was still locked and the metal door frame had broken.

We searched the building with Squad 628, OFC B. CARON and his K9, and failed to located any suspects.

It appeared that the two cash registers at the front of the store had been ripped out of the counter and taken. It did not appear as if any other property was taken.

OFC K. GRUNDHAUSER reviewed the surveillance footage and observed the suspect wearing a camouflaged jacket and pants, black gloves and hat, and a black facemask, carrying what appeared to be a crow bar. OFC K. GRUNDHAUSER observed the suspect head into the ravine to the north west of the store with the cash registers at approximately 0230 hours. No key holders responded to the scene to provide a copy of the surveillance footage. We contacted a board up crew to secure the front entrance of the store. We left two business cards containing case numbers for the incident, one posted on the front door, and one on the front counter.

We located fresh footprints in the area that OFC K. GRUNDHAUSER observed the suspect enter the wood line. We followed the tracks down into the ravine. The tracks continued north west and crossed the rail road tracks. Approximately 10 feet from the rail road tracks, under the Rice St overpass, we located the two cash registers left behind by the suspect. One cash register had been broken into and the money taken. The second register was damaged but not breached.

We continued to follow the footprints until they terminated at the southwestern gate of Demrio's Storage Facility, 1379 Rice St.. The front entrance to the Facility is an open entrance. We observed numerous surveillance cameras through out the facility.

We recovered the cash register's and loose change (\$1.23), and turned them in at the property room.
