NOTICE OF INTENT TO DENY LICENSE

Dear Applicant:

The Department of Safety and Inspections will recommend denial of the Auto Repair Garage license application submitted by Integrity Auto Sales, LLC d/b/a Integrity Auto Sales for the premises located at 501 Maryland Avenue West, Suite B in Saint Paul. The basis for the recommendation is based on the following information:

On June 19, 2017, you were sent a letter from the Department of Safety and Inspections by US Mail and then emailed to stevebartlett651mn@yahoo.com stating your Auto Repair Garage license application was still pending until the requirements listed below were met by August 1, 2017:

- Obtain City Building Official approval for the change in use occurring within the building (i.e., establishment of the auto repair use) by completing the following:
 - 1. Obtain a Sewer Availability Charge (SAC) determination
 - 2. Complete all actions necessary so that the ventilation system is complaint with applicable code discipline requirements for an auto repair use
 - 3. Obtain all necessary building and/or trade permit(s) and inspection approval(s) so that the space can be certified for an auto repair use.

As of today, DSI has not received a response from you with submission of the required information to continue the application process.

In addition, on August 4, 2017, an inspector came to the licensed premises and took photographs showing the gate was locked and no activity. Photographs also showed that the following required improvements have not been made to the property since the initial opening inspection:

You have not striped all the parking spaces in violation of license condition #4 of the Zoning Conditional Use Permit (CUP) Permit #15-144494:: "All parking spaces shall be striped." and license condition #9: "The parking lot shall be maintained in accordance with the approved site plan on file with DSI dated 10/12/2015. This includes striping of the parking lot, installation of customer/employee parking signage, repair/maintenance of the asphalt surface area, landscaping and fencing. Improvements and installation of customer/employee parking signage on the site must be completed by 06/01/2016."

At this time, you have four (4) options on how to proceed:

- 1. If I have not heard from you by **Friday**, **September 8**, **2017**, I will presume that you have chosen not to contest the proposed adverse action, and the matter will be placed on the next available City Council Agenda for approval of the proposed remedy.
- 2. If you wish to admit the facts but you contest the penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing. I will need to receive your letter by Friday, September 8, 2017. The matter will then be scheduled before the City Council to determine whether to deny your Auto Repair Garage license. You will have an opportunity to appear before the City Council and make a statement on your own behalf.
- If you <u>dispute the facts</u> outlined above, you may request a hearing before an Administrative Law Judge (ALJ). You will need to send me a letter disputing the facts and requesting an administrative hearing no later than Friday, September 8, 2017. At that hearing both you and the City will appear and present witnesses, evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify or reject the ALJ's report and recommendation.
 - Please note: If you choose an administrative hearing, the Department of Safety and Inspections reserves the right to request that City Council impose the costs of the administrative hearing per Saint Paul Legislative Code § 310.05 (k).
- 4. You can withdraw your Auto Repair Garage license application. Please complete and return the enclosed REQUEST TO WITHDRAW form to the Department of Safety and Inspections (DSI), 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than Friday, September 8, 2017. Any request for a refund of the license application fee must also be made in writing to the Department of Safety and Inspections.

If you have not contacted me by Friday, September 8, 2017, I will assume that you do not contest the denial of your Auto Repair Garage license. In that case, the matter will be placed on the next available City Council Consent Agenda for approval of the recommended penalty.
