Our records indicate that a permit was issued to Clifton Holliday on Monday June 02, 2014 for construction of a fence. The fence constructed under permit # 14 293125 has been constructed illegally in the public right of way along Riverview Avenue and must be removed immediately.

This is the 3rd and final letter issued on this matter. An Encroachment Permit Request for fence was denied from Public Works on December 10, 2014. Legal action or a citation will follow if no action is taken to resolve this issue.

Within seven (7) days of the date of this letter, the exterior work authorized by permit # 14 293125 must be completed, property pins exposed and an inspection called for to close the permit.
