The construction will be held at the following locations:

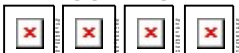
Site 1: 428 Mississippi River Boulevard S
Site 2: 356 Mississippi River Boulevard S (Located on Jefferson)
Site 3: 270 Mississippi River Boulevard S (Located on the Boulevard)
Site 4: 186 Mississippi River Boulevard S - (Located on Princeton)
Site 5: 2260 Summit Avenue (Located on the Bike Path on Mississippi R Blvd)
Site 6: 2260 Summit Avenue (Located on the Boulevard)
Site 7: 145 Otis Avenue
