**NARRATIVE**

NO ICC VIDEO AVAILABLE FOR SQUAD #1093.

On 12/31/2012 at 0459 hours, squad 140 (Higgins) was sent to 595 N. Snelling Avenue (Mosaic on a Stick) to take a burglary report. A passerby (Dave BENSON, 651-644-4689) called to report that the glass on the front door to the business was smashed.

I arrived on scene and found the front door to the business smashed out. I entered the business and found no suspects inside. It appeared that the suspect(s) entered the business and rifled through some papers on the front desk. The business has no alarm system or security cameras.

I found a cell number for the business owner (GREENE, Lori (NMN), W/F, 06/28/1965, 1632 Blair Avenue, St Paul, MN 55104, Cell: 651-246-7218) by looking up an old report call in RMS.

I called GREENE and advised her that her business had been broken into. GREENE was out of town for the holidays and was unable to respond to the scene. GREENE walked me through the store (by phone) and it was determined that the suspect(s) probably didn't steal anything of value, if anything at all. I found a cash box in a back room that had money in it and the cash register up front was left empty when GREENE last closed the store up. GREENE told me the cash box should have approximately \$100-200 cash in it. I did not count the money in the cash box, but it appeared to be about \$100-200 cash. I left the cash box in the back room at GREENE'S request. It should be noted that the cash box would not secure. GREENE told me that the lock on the cash box was broken prior to the burglary and would not lock.

I gave GREENE this case number and my name. At GREENE'S request, I called out a board-up crew to have the business secured.

I took photos of the scene and later downloaded the photos into the Media Vault.

No suspects at this time.
