Sqd. 322, Sherwood, sent to 1659 N. Luella St. to assist SPFD Medic 9 who had to force open a door for a medical emergency and were in need of the premise to be secured as they had to transport the resident to St. John's hospital.

Fire paramedics advised me that they had to force open the front door as well as break a window in the door to gain access. There were no family or neighbors to secure the residence and they had called for a boarding crew. They turned over to me the keys to the house.

The resident; EMMS, MARION, W/F, 92 YRS, was transported to St. Johns Hospital, (Maplewood).

Sqd. 390, Officer Alberg, photographed the damage to the door.

At 0910 hrs the boarding crew, (Restoration Specialists), responded and secured the front door. The rest of the house was checked to see that it was secure. The house was found secure and i exited through the rear entry door, locking it as I left.

At 0945 hrs, I left the address and delivered the keys to the house to St. Johns ER nursing staff. Emms was in Xray at the time of my arrival.
