My Grandfather was part Siksikaitsitapi or Blackfoot Canadian from Quebec. His family came to Saint Paul in the 1860's and we have been here ever since. When I was young I asked him, "Why are there no people who look like us here?" His response, "Well honey, there used to be. Before our family came from Canada. They (Sioux) used to live up on the hill." Then he would point to Hillcrest. Hillcrest is Native land. Give it back to ALL people, in the care of the Dakota, in the form of a park. When the public finds out that Native American artifacts were found nearby, and when more are found at Hillcrest, there will be an uproar. Return our land to all of us! Let the People care for this beautiful green space!

I am a bleeding heart liberal who believes in the golden rule. I had the opportunity to go door to door and talk with residents. Here is what they said.
