**Synopsis :**

Death investigation of a male on the 1700 block of VanBuren Ave. occurred at approx. 0930 on 04-23-24.

**Narrative :**

No ICC. We were wearing and had activated our BWC's. We did not review the video.

We arrived and spoke with the Medics #20 (run 19174). Along with medics was the comp IDed as Danielson, Terra (DOB/1980-05-27). Danielson stated she had contact with the deceased later IDed as Hallberg, Scott Brian (DOB/1956-05-10) on 04-20-24 at approx. 0630. At that time he stated to her that he had fallen and had a difficult time getting back up. Danielson knew he was diabetic and had other medical conditions. She had tried to make phone contact with him since then with no success.

We knocked on the door with no answer. Danielson tried calling his number with no answer but we could hear the phone ringing in the unit. Hallbergs car was parked in its normal spot. An unidentified neighbor stated he sees Hallberg on a daily basis but had not in the last three day. The deadbolt lock was secured. We confirmed with medic 20 that they believed there was a medical need to check on Hallberg. Medics forced the door and we found Hallberg deceased on the floor of his bedroom. Medics pronounced him deceased at 0944. There was no sign of a struggle of assault. There was no illegal drugs found.

Hallberg lived alone with no pets.

I cleared with Sgt Labarre and contacted the medical examiner who released the body to the family. ME CN 24-1276.

I was able to find a phone book with sibling contacts in the apartment. Sister IDed as Hallberg, Kimberly Robin (DOB/1965-04-30) was notified. K. Hallberg contacted Crescent Tide of St Paul who responded and took the body. Nobody from the family came to the scene.

I also notified a brother of the deceased IDed as Christopher Hallberg.

We contacted a board up crew from the city to secure the apartment.
