That said, it is my understanding that you're considered a "swing vote" regarding the makeup of the St. Paul PCIARC, and the ongoing debate on whether it is appropriate to include police officers on the commission. To me it seems redundant and a clear conflict of interest: the police department already has an internal affairs unit. The intention of this Commission should be a true civilian voice to add a check and balance to their work.

Subject: Support an independent all-civilian police review commission

Dear Councilmember Prince,

I'm a Saint Paul resident, with family in Ward 7 who will be attending the meeting tonight. I am writing to encourage you to support an all-civilian police internal affairs review board, as outlined in two separate audits and modeled in countless other cities throughout the country. While I appreciate some of the reforms that have been proposed, keeping police on the commission in nonvoting capacity does nothing to address concerns about the impact on the board's independence and ability to render unbiased judgments.

Our region is suffering from strained relationships between law enforcement and communities. Shootings death by police hit a record high this year in Minnesota. There is widespread perception that policing procedures are rigged against communities, and set up to allow departments to "protect their own" at the expense of citizens who may have rightful complaints. Following the lead of other commissions and the two audits, an independent civilian review board could be an important step in building trust.

The department has sufficient opportunity for input into the commission, and commissioners are trained and develop expertise and experience over time. Police participation in the commission, even in a nonvoting role, does not add to commissioners' ability to weigh and deliberate cases, and instead jeopardizes the legitimacy and independence of the process. Our city, communities, and police department will benefit from a fully independent citizen review board, that can provide the thoughtful analysis and reflection of the dedicated laypeople who serve on the commission.

I have read both the U of M report and Berkshire reports carefully, which compellingly argue for an independent process due to the risk of influence and bias. Police officers do important and difficult work, and the investigation should reflect department policies and other relevant information. But having police participate in the commission's deliberations makes no more sense than allowing a member of the prosecution or defense team to participate in the deliberations of a jury.

The jury process works when jurors are truly independent and each can participate in the dialogue on an equal footing. Police department staff who participate in the commission can never be truly independent, nor will they be on equal footing with other commission members because they have and are seen to have special expertise. I share the belief, with many other residents and voters, that police do not belong on a civilian review board.

I ask for your support for an independent and all-civilian review board. Our residents need to trust in the integrity and impartiality of the process.

It has also come to my attention that Councilmember Thao will be out of town on Wednesday. For the purpose of good process and in recognition of the years of work that have happened around reforming the commission, I hope you will support laying over the vote on the PCIRAC reform until a time when all councilmembers can be present.

I would be happy to speak with you further about my concerns with this issue.

One example that comes to mind is the placement of SRO's within Saint Paul Public Schools. I went to Central High School where there was a SRO named Officer Kraus was present every day and while I was painfully unaware of it while I was in school, I soon became aware of the unjust lack of accountability and bias that this SRO held towards students of color. For example, there were multiple complaints made by students citing racial insensitivity and unjust use of force upon students by him and despite the influx of complaints, the administration made no effort to store and file these complaints. One instance was videotaped and garnered large amounts of attention and disgust from local members who voiced their concern and disdain for his actions. He has exhibited culturally insensitivity towards students, particularly those of the muslim community in an environment that is supposed to be welcoming and nurturing. It is my belief that this lack of accountability both by the school and the police department resulted in his belief that he could use excessive force on students and get away with it. This is just a personal example, I have heard of multiple instances of local police having zero accountability for their actions from trusted friends and family members as well, purely because they are being examined by other police.

This board is incredibly important, and the city council has the opportunity to be a better model for police accountability and restore residents' confidence in the board.
