## MAJOR PROBLEMS WITH CITY OF ST. PAUL TRASH SERVICE WHICH I DO NOT NEED!

1. I live elsewhere in the winter and generate NO trash in St. Paul, why am I forced to pay for expensive trash service which is NOT USED? **I should be 100% exempt from billing!**
2. I am billed about \$100 for a way too big trash can that I have never used because:
3. I am a 79 year old veteran with a disability on fixed poverty level income.
4. To save money . . . every fall I drain the plumbing system and live elsewhere all winter. Water Department records show that no city water is used during the winter (see zero water used on water bill on reverse side).
5. Many City residents go south for the winter and should be exempt from winter trash billing.
6. Each snowfall costs \$100 to plow my 375' long driveway, which I cannot afford to pay.
7. Without a snow plowed driveway the way too big trash can cannot be moved to the curb.
8. TO REITERATE: I live elsewhere in the winter and generate NO trash in St. Paul, why am I forced to pay for expensive trash service which is NOT USED?

**I should be 100% exempt from billing!**

Anderson composts his garbage on his property year round. Anderson's property is not vacant. Anderson receives his mail, votes and maintains his garden, trees and his property.
