NOTICE OF INTENT TO SUSPEND LICENSE

RE: Restaurant (4) – 51-150 Seats license held by My Living Room Café, LLC d/b/a My Living Room Café, LLC for the premises located at 2038 Marshall Avenue in Saint Paul

Dear Say Her Vang:

The Department of Safety and Inspections (DSI) has recommended suspension of the Restaurant (4) – 51-150 Seats license held by My Living Room Café, LLC d/b/a My Living Room Café, LLC for the premises located at 2038 Marshall Avenue in Saint Paul. The basis for the recommendation is as follows:

On May 31, 2011, you were sent a letter and RENEWAL INVOICE from the Department of Safety and Inspections (DSI) stating that your Restaurant (4) – 51-150 Seats license expired as of January 29, 2011. You now owe \$983.00 in delinquent license and late fees.

You were also asked to complete the Alarm Permit questionnaire at the bottom of the renewal invoice and submit a completed Certificate of Compliance Minnesota Workers' Compensation Law form. You were given until June 21, 2011, to pay the delinquent license and late fees and submit the requested information. As of today's it has not been received.

In addition to the suspension of your Restaurant (4) – 51-150 Seats license, per Saint Paul Legislative Code §310.05 (m) (2), the licensing office will also recommend a \$500.00 matrix penalty for failure to submit required information in order to maintain your license.

At this time, you have three options on how to proceed:

1. You can pay the delinquent license and late fees and submit the requested information. If this is your choice, you should send the payment and information directly to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Friday, July 8, 2011**. Information should be directed to the attention of Christine Rozek. A self-addressed envelope is enclosed for your convenience. Payment of the delinquent license and late fees and submission of the requested information will be considered to be a waiver of the hearing to which you are entitled.
2. If you wish to admit the facts but contest the penalty, you may have a public hearing before the Saint Paul City Council, you will need to send me a letter with a statement admitting the facts and requesting a public hearing. We will need to receive your letter by **Friday, July 8, 2011**. The matter will then be scheduled before the City Council for a public hearing to determine whether to suspend your license and impose the \$500.00 matrix penalty. You will have an opportunity to appear before the Council and make a statement on your own behalf.
3. If you no longer wish to do business in the City of Saint Paul, you will need to send a written statement to that effect to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Friday, July 8, 2011**. Information should be directed to the attention of Christine Rozek.

If you have not contacted me by Friday, July 8, 2011, I will assume that you do not contest the suspension of your license and imposition of the \$500.00 matrix penalty. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
