The retaining wall on the East side of the property is leaning over and has large cracks and holes on the wall.
- Exterior Throughout SPLC 34.08(5), 34.32(3) All accessory structures including, but not limited to, detached 2. garages, sheds and fences shall be maintained structurally sound and in good repair. Provide and maintain exterior unprotected surfaces painted or protected from the elements. The chain link fence on the East side of the property is not well maintained. The wooden fence boards are not well maintained and are leaning.
