Dear Sir or Madam:

The City of Saint Paul, Department of Department of Safety and Inspections has inspected the above referenced property on **May 06, 2008** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code<sup>1</sup>:

1. The exterior walls of the house are defective. Repair all holes, breaks, loose or rotting siding/replace missing siding, to a professional state of maintenance.
2. The exterior walls of the garage are defective. Repair all holes, breaks, loose or rotting siding/replace missing siding, to a professional state of maintenance.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will reinspect these premises on or after **June 13, 2008**, by which date the violations noted must be corrected. **Failure to correct these deficiencies may result in the issuance of criminal charges<sup>2</sup>** and/or a civil lawsuit, and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-9090.

You may file an appeal to this notice by contacting the City Clerk's Office at 651-266-8688. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal, and pay a filing fee.)
