Councilmember Helgen said he had had several conversations with Mr. Kamp, and it appeared Mr. Kamp had made a sincere effort to understand and respond to the violation. Councilmember Helgen moved to amend the resolution to impose a \$250 fine and suspend the remaining \$250 for eighteen months as long as there were no additional violations.

29. Third Reading – 10-1013 – An ordinance memorializing City Council action approving the rezoning from B2 Community Business to TN2 Traditional Neighborhood for property at 2186 Marshall Avenue. [ZF 10-511-437] [Public hearing held August 18, 2010]

30. Second Reading – 10-1031 – An ordinance amending Chapters 87, 90, and 94 of the Saint Paul Legislative Code pertaining to the rules and regulations of the Board of Water Commissioners.

31. First Reading – 10-1096 – An ordinance adopting the Geographic Information Systems (GIS) based zoning map as the official zoning map.

Councilmember Thune said that at 4:00 p.m. there would be a demonstration of a new form of seasonal sidewalk on Sixth Street in Lowertown.

Councilmember Carter announced that St. Paul was one of 21 communities to receive a \$500,000 Promise Neighborhoods grant. He thanked the Mayor, County Commissioners, St. Paul Schools Superintendent, Board, and staff, City staff, and community partners.
