NOTICE OF PUBLIC HEARING

Team Ortho Foundation Women ROCK Race Event

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request.

Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance:

Location: Mississippi River Blvd, South of Ford Pkwy near Lock and Dam No. 1 Site

Noise Source: Team Ortho Foundation has requested a sound level variance to present outdoor music and the use of a sound system for announcements on Saturday, August 30, 2014 at Mississippi River Blvd, South of Ford Pkwy near Lock and Dam No. 1 Site. The variance is requested for the hours of 8:00 a.m. to 10:00 a.m. on Saturday, August 30, 2014. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 8:00 a.m. to 10:00 a.m. at Mississippi River Blvd, South of Ford Pkwy near Lock and Dam No. 1 Site for the Event on Saturday, August 30, 2014. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 a.m. at the Mississippi River Blvd, South of Ford Pkwy near Lock and Dam No. 1 Site on the date of the event.
