#### Legal Description Contained in Document No.'s 2144410 and 4251181

Those parts of the following described tracts of land lying Southerly of a line which is 100 feet Northerly and parallel to the North line of Block 4, Bazil and Roberts Addition to West St. Paul (sometimes referred to in the records as Bazille and Roberts Addition to West St. Paul) and within a strip of land 50 feet in width the Easterly line of said strip being the Easterly line of Starkey Street as platted between Blocks 175 and 176 Robertson's Addition to West Saint Paul produced Northerly and the Westerly line of said strip being a line 50 feet Westerly and parallel to the Easterly line of Starkey Street produced Northerly.


