Locations: Locations within Union Park District Council 13: Summit Avenue and Cretin-Cleveland Avenues; Summit Avenue and Prior Avenue North-Howell Street; Mississippi River Blvd and Marshall Avenue; Summit Avenue and Saratoga Street North- Fry Street North

Noise Source: Twin Cities in Motion has applied for a sound level variance in order to provide amplified sound for announcements, speakers and/or music, from 7:00 a.m. to 2:30 p.m., with a pre-event sound check from 6:30 a.m. until 7:00 a.m. on Sunday, October 1, 2017 at Summit Avenue and Cretin-Cleveland Avenues; Summit Avenue and Prior Avenue North-Howell Street; Mississippi River Blvd and Marshall Avenue . The Department of Safety and Inspections recommends the following conditions: 1) Variance will be for the hours of 7:00 a.m. to 2:30 p.m., with a pre-event sound check from 6:30 a.m. until 7:00 a.m. on Sunday, October 1, 2017 at the above listed Locations. 2) All electronically powered equipment used in conjunction with the event must not exceed 80 dBA as measured 50 feet from sound source. 3) The applicant will provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices will be turned off no later than 2:30 p.m. on Sunday, October 1, 2017, the date of the event.
