INTERDEPARTMENTAL MEMO OF UNDERSTANDING

In accordance with the decision of the Director of the Department of Planning and Economic Development, made by authority granted under Resolution # 15-1445, adopted on August 19, 2015, the Department of Parks and Recreation will administer the Commercial Vitality Zone (CVZ) Project entitled Hamm Park Improvements. Work on this project is expected to commence on June ___, 2018 and be completed on or about October, 2018.

CVZ funds in the amount of at least \$ 70,000.00 have been allocated for the construction of this project. Any additional allocation of CVZ funds must be documented in writing and agreed to by the Directors of PED and Parks and Recreation or their respective designees. As work progresses, the Department of Parks and Recreation will bill the CVZ Program using the City's ID billing system. The disbursement code is: 1-28551400-73220-51400-10008-73220.

Attached to the ID will be an accounting of actual bid item costs on the project which corresponds to the requested reimbursement amount and matching dollars spent on the project.

In addition, all applicable compliance requirements regarding Affirmative Action (Section 183.04 of the Saint Paul Legislative Code), Labor Standards (Section 82.07 of the St. Paul Administrative Code) and the Vendor Outreach Program (Chapter 84 of the St. Paul Administrative Code) need to be satisfied prior to a CVZ reimbursement.
