OFC's did a welfare check on them and it appeared they had consumed alcoholic beverages (due to smell, bloodshot and watery eyes, and self admission) and also smelled strongly of marijuana smoke. OFC was approached by an adult male, who stated he is leasing the address "All Nations Barbers" from an older Asian female. This male also said he runs a "social club" at this address, and it is normally Muslim males who pay into a membership, and have access to the address to play cards and watch sports. The male said this "social club" is normally open from 1200 hours to 1800 -2000 hours. He said there is not liquor at the address and no money is exchanged for the card playing etc. The male then said he was short on money this month, and had allowed another group to rent this space out for an "after party event" at this address. I observed at 0419 hours on 06/24/2021, there were still a large amount of foot traffic in the area (30). This male said the after party had two security officers who were in charge of the party, I observed two large males who appeared to be standing near the doors, but they were making no attempts in checking individuals coming and going from the address. I asked if I could see the interior of the address, and the male was hesitant and said he rented it to another group. While standing in the driveway to the address (east), I observed multiple individuals smoking marijuana on the upper deck area. I also observed dance lighting inside. OFC's never made entry. I also could not confirm if there was alcohol being sold at this address, due to the time (0419 hours) and it appeared, there were a few individuals, who were highly intoxicated from alcoholic beverages, at a minimum, alcoholic beverages were allowed to brought into the address and consumed.

I further spoke to the male who stated he was looking at hiring police officers for future events at the address. I instructed the male, it would unlikely to be approved, due to the grounds of the address and liquor being consumed also at the address.
