Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting has been scheduled for **Wednesday, January 18, 2012 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse.

This is an uncontested matter concerning the fact that on December 1, 2011, you failed a tobacco compliance check by selling tobacco products to a minor in violation of Minn. Stat. § 609.685 and Saint Paul Legislative Code § 324.07 (c). Due to the fact that this is the third (3rd) violation within the past eighteen (18) months, the licensing office will recommend a thirty (30) day suspension of your Cigarette/Tobacco license.
