I-35E Encampment: Closed on Sept. 10, 2020

- As outlined in our August presentation, the encampment sites around the I-35E off ramp, along Cathedral Hill Pathway, and History Center steps had public safety risk factors that required closure of that site.
- The numbers had grown from about 5 tents in March to more than 50 tents and about 80 individuals sheltering in the area by late August.
- The City worked with outreach staff and partners, as well as <u>directly with</u>
 <u>encampment occupants</u> in the days before the clearing to identify indoor
 options for <u>everyone</u>.
- The number of occupants the day of the clearing was 30-35.



I-35E Encampment Closure: Combined new and proven strategies/approaches

- Notified occupants early and often about when the area would be cleared
- Visited multiple times before Sept. 10, assessed individuals' needs, and identified alternate housing options.
- Determined in advance the number of spaces needed, and confirmed through Ramsey County what shelter or housing options were available:

I-35E Encampment Closure: Combined new and proven strategies/approaches

All non-profit and public sector partners were coordinating resources to overcome barriers – <u>transportation</u>, <u>storage</u> for belongings, <u>day space options</u> for transition to indoor space.

- 6 Higher Ground
- 2 Union Gospel Mission
- 6 Safe Space
- 3 Hotels
- 1 Hospital referral
- 1 Minneapolis (housing voucher)
- 1 Hotel/HAT voucher
- 4 relocated to Lower Landing

I-35E Encampment Closure: Next steps and Challenges

- Requested MNDOT/State assistance to ensure this state-owned property remains clear.
- Independent volunteers transported individuals to various locations without coordination (not able to track/need to ensure case workers know where their client re-located)
- The Phalen location that individuals from I-35E were taken has specific challenges:
 - too far from downtown services; individuals do not have transportation to get to caseworker meetings, medical appointments, etc.
 - not already determined to be supported with sanitation services

ACTION PLAN 1 (Long-term Plan)

Issue to solve

 Significant increased need for shelter, housing supports, and affordable housing options for individuals experiencing homelessness as a result of COVID-19

Primary strategy

- Identify new housing and shelter spaces that meet specific needs of those experiencing homelessness
- Provide more options for 24/7 with wrap-around services, as well as more "day-space" locations and services.

Progress

- Funding matrix in place
- Four to five potential sites identified; need to be fully evaluated
- Broker working with City to help assess readiness, feasibility



ACTION PLAN 2 (Immediate Response)

<u>Issue to solve:</u> Significant increased need for supports for individuals experiencing homelessness as a result of COVID-19

<u>Primary strategy:</u> Mobilize and coordinate resources of all partners to get individuals indoors and on pathways to housing and supports they need

Secondary strategy: Directly support the current needs of occupants at temporary encampments:

- InvolveMN partnering now with City to provide up to 500 meals a day, delivered directly to sites
- Coordinated trash pick-up services and sanitary services
- Safety and security
 - SPPD added patrols
 - New Block by Block Ambassadors program (starts operations today)
- Continue site by site approach Area Operational Plans
