I reported this problem to you on 11/26. The unsightly fence is still up. It was built without a permit. It is in violation of Minnesota Statute 561.02 which prohibits spite fences, and of the blight ordinance of Minn. Stat. Ann 344.03. It was built two days after my neighbor was served with a non-harassment restraining order. Refuse has also been piled next to property line.
