Applicant John Neubauer - The applicant is proposing to convert the former site of the Northern Pacific Railway Company's Como Shops - Blacksmith Shop located just north of Bandana Square into an event center/reception hall. There are two buildings on the property totaling 22,171 square feet of gross floor area. The existing parking lot located on the property has 40 parking spaces and the applicant intends to increase the parking lot capacity to 59 spaces; the new use will require 106 parking spaces. The applicant is proposing to provide, under a lease agreement, the remaining additional 47 parking spaces at the parking lot facility for the Best Western Plus Hotel located west of the hotel building. The zoning code requires that off-site parking must be located within 300 feet of the building it is intended to serve; the hotel parking facility is 502 feet away, for a variance request of 202 feet.
