This is a notice of appeal of the decisions made by Marcia Moermond at the hearing on Wednesday, August 25, 2021.

I told Ms. Moermond this, and her response was to rush the Kangaroo Court process as fast as she could.

I was away all day, at medical appointments and visiting my mother. It is evening and I find that she has ordered me out of my house, prior to your ever having a chance to review her recommendation, even though she does not have this authority.

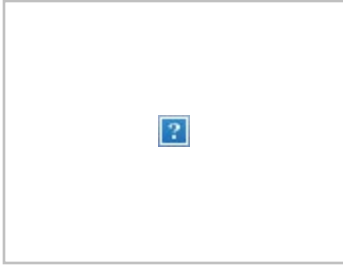
