C-160163	Michael F. Rogosheske 799 Holton Street, Saint Paul, MN 55104	On 10/04/2016 SPRWS received a call from Roto Rooter which was repairing a broken sanitary sewer at 799 Holton. We investigated the damaged sewer and determined that while replacing a 6-inch CI main with 8-inch HDPE pipe in the fall of 2015, the bucket of our backhoe struck the sewer.	\$5,451.42
C-170045	Agnello E. Ross, 2091 Wellesley Avenue, Saint Paul, MN 55105	A main break on 1/19/2017 on Winifred St. and Charlton St. resulted in excessive water pressure and damaged a sanitary sewer service to 205 Winifred St. W. Water and sewer backed up into the claimant's home. On 1/20/2017, SPRWS hired a contractor to repair the sewer service. On 1/24/2017 SPRWS repaired a leaking valve on the claimant's water service connection. SPRWS inspected the home on 1/25/2017 and found 4 inches of sewage in the basement. SPRWS was aware the pressure reducing valve in the area was not working properly and had plans to replace it. Unfortunately, the water main broke prior to SPRWS accomplishing the valve replacement. The pressure reducing valve has since been replaced. The claim is for the cost of cleanup of sewage in the home.	\$1,340.00
C-170051	John R. Purdy 10 W. Delos Street, Saint Paul, MN 55017	SPRWS instructed claimant to purchase two pressure reducing valves at his own expense as a solution to high pressure in the area. Shortly thereafter, SPRWS determined the need for the valves arose from a defective pressure reducing valve in the pressure zone. When the pressure reducing valve was replaced, the customer's water pressure was returned to normal and there was no need for pressure reducing valves on the private water service connection. Accordingly, SPRWS notified the customer and agreed to pay for cost of the pressure reducing valves SPRWS had mistakenly directed the customer to install.	\$100.00

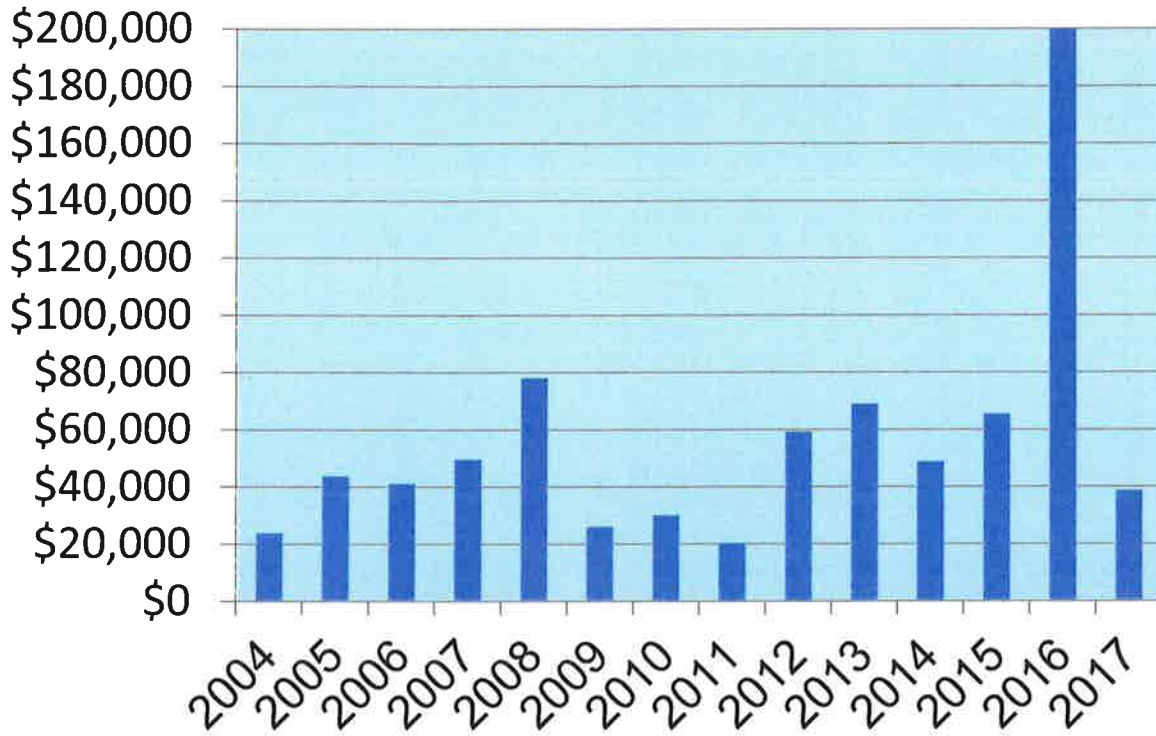

C-170058	USAA (United Services Automobile Association) 530 B Street, 8th Floor, San Diego, CA 92101 on behalf of their client Ross Niebur	On 2/4/2016, SPRWS truck was northbound on Hwy. 52 and rear-ended stopped vehicle #2 Xcel truck ahead of him, pushing it into vehicle #3 claimant's vehicle.	\$2,751.08
C-170059	Xcel Engery, 414 Nicollet Mall, Floor 8, Minneapolis, MN 55401	On 11/22/2016, SPRWS crews were working on a lead replacement at 1288 Juno Ave. While backfilling the trench, SPRWS nicked an Xcel gas main.	\$861.75
C-170074	Darla J. Taylor 1869 Hwy 96, White Bear Lake, MN 55110	On February 3, 2017 SPRWS tandem dump truck lost some loose gravel/rock that cracked the windshield of the claimant's vehicle. The claim was for windshield replacement.	\$239.27
C-170076		On March 28, 2017, the claimant's vehicle [Ford F150 Pick-up] was parked on Wabasha South of 7th in Saint Paul. SPRWS Truck 616 struck the left side of the parked vehicle.	\$6,782.75

As a result, the claimant's car, parked to the east of the SPRWS truck, was hit in the driver's side mirror.	\$503.49
C-170136	Rayvon S. Smith, 875 Burr Street #2, Saint Paul, MN 55106	On 6/19/2017 SPRWS truck #640 with air compressor was headed north on Rice St. in the west lane. The driver of claimant's truck was also headed north on Rice St. in the east lane. A third driver ahead of of SPRWS was making a left hand turn that caused SPRWS to change lanes. In doing so, the SPRWS truck hit the claimant's truck, forcing it into a light pole. SPRWS driver was cited for unsafe change of course.	\$3,815.60

SPRWS sent out employee who determined the sewer was damaged. SPRWS repaired claimant's sewer on 6/11/2017. Earlier in the spring, SPRWS had conducted lead replacements on Smith Ave. at this location, damaging the sewer. SPRWS admits damage to the sewer and responsibility for repairs. The claim was for replacement of damaged area rugs.	\$452.00
C-170166	Xcel Engery, 401 Nicollet Mall, Minneapolis, MN 55401	On 5/24/2017 SPRWS worked on a lead replacement at 830 Smith Ave. S. During excavation, SPRWS hit and damaged a gas line with the backhoe.	\$809.98
