Location: Median between east and west bound lanes of Summit Avenue at Mississippi River Blvd

Noise Source: Team Ortho Foundation has requested a sound level variance to provide the use of a mobile DJ sound system for runners for the Monster Dash Event. The variance is requested for the hours of 8:30 a.m. until 10:00 a.m., with a pre-event sound check at 8:15 a.m. at the median between east and east bound lanes of Summit Avenue at Mississippi River Blvd on Saturday, October 31, 2015. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 8:30 a.m. to 10:00 a.m., with a pre-event sound check at 8:15 a.m. at the median between east and west bound lanes of Summit Avenue at Mississippi River Blvd on Saturday, October 31, 2015. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA as measured 50 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 a.m. on the date of the event.
