Dear Mr. Maarouf:

The Department of Safety and Inspections received a letter from you on November 21, 2012, in response to the Notice of Violation dated November 1, 2012. You were given three (3) options on how to proceed: 1) pay the \$500.00 matrix penalty; 2) admit to the facts but contest the \$500.00 matrix penalty by requesting a public hearing and 3) contest the facts and the \$500.00 matrix penalty by requesting an administrative hearing. In your response letter, you admit to the facts and request that the fine be waived. This response is considered a request for a public hearing before City Council.

Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting scheduled for **Wednesday**, **December 19**, **2012 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse.

Enclosed are copies of the resolution and supporting documents which will be presented to the City Council for their consideration. This is an uncontested matter concerning the fact that you were not able to provide Saint Paul Police a copy of video surveillance dealing with an incident that occurred at your establishment on October 23, 2012. Failure to provide a copy of video surveillance upon request to the Saint Paul Police Department is a violation of license condition #2; therefore, the licensing office will recommend a \$500.00 matrix penalty.

If there is any information you wish to present to the Council for their consideration before the public hearing, please send it to me no later than Monday December 10, 2012.
