PLEASE REMOVE ALL ALUMINUM CANS, TIRES, TOTES, TRASH, FURNITURE, HOUSEHOLD ITEMS, SCRAP WOOD AND MISCELLANEOUS DEBRIS FROM THE ENTIRE YARD AND DRIVEWAY AREA; PLEASE REMOVE ALL STORAGE FROM THE INTERIOR OF THE VEHICLES IN THE DRIVEWAY. THANK YOU. Comply before December 7, 2017

If you do not correct the nuisance or file an appeal before December 07, 2017, the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes.

Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.
