NOTICE OF INTENT TO SUSPEND LICENSE

RE: Tanning Facility license held by CKF Holdings, Inc. d/b/a Perfect Tan for the premises located at 373 Pedersen Street, Unit #103 in Saint Paul

Dear Mr. Frank:

The Department of Safety and Inspections (DSI) has recommended suspension of the Tanning Facility license held by CKF Holdings, Inc. d/b/a Perfect Tan for the premises located at 373 Pedersen Street, Unit 103 in Saint Paul. The basis for the recommendation is as follows:

**On December 9, 2013, you were sent a letter and RENEWAL INVOICE from the Department of Safety and Inspections (DSI) stating your Tanning Facility license expired as of October 5, 2013. You currently owe \$126.00 in delinquent license and late fees.**

**You were also asked to submit the following information with you license fee payment: 1) a list of tanning equipment including manufacturer's name, model #, type (booth, bed, canopy, etc..) year manufactured and number in the establishment; 2) a copy of your Tax ID or Social Security Number and 3) a completed Certificate of Compliance Minnesota Workers' Compensation Law form. You were given until December 30, 2013, to pay the license and late fees and submit the required information. As of today's date, neither has been received.**

In addition to the suspension of your Tanning Facility license, per Saint Paul Legislative Code §310.05 (m) (2), the licensing office will also recommend a \$500.00 matrix penalty for failure to submit the required information in order to maintain your license.

At this time, you have three options how to proceed:


1. You can pay the delinquent license and late fees and submit the required information. If this is your choice, you should send the payment and information directly to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Friday, January 24, 2014**. A self-addressed envelope is enclosed for your convenience. Payment of the delinquent license and late fees and submission of the required information will be considered to be a waiver of the hearing to which you are entitled.

2. If you wish to admit the facts but contest the penalty, you may have a public hearing before the Saint Paul City Council, you will need to send me a letter with a statement admitting the facts and requesting a public hearing. I will need to receive your letter by **Friday, January 24, 2014**. The matter will then be scheduled before the City Council for a public hearing to determine whether to suspend your Tanning Facility license and impose the \$500.00 matrix penalty. You will have an opportunity to appear before the Council and make a statement on your own behalf.
3. If you no longer wish to do business in the City of Saint Paul, you will need to send a written statement to that effect to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Friday, January 24, 2014**. Information should be directed to the attention of Kristina Schweinler.

**If you have not contacted me by Friday, January 24, 2014, I will assume that you do not contest the suspension of your Tanning Facility license and imposition of the \$500.00 matrix penalty. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.**


