I am forwarding the notes provided to me from the sanitation crew who worked on Mr. Anderson's home yesterday. The smell is still very strong, as the cat urine has penetrated through everything in his home. Gordon has been working very hard to correct this situation, but, I am not sure that it will be enough for South Metro contractors for the water heater or Warner Stallion for his refrigerator. South Metro states that soonest that they can come out to evaluate for the water heater is Tuesday, August 2. The refrigerator is on order and I have been told it could take 2 weeks to be delivered. Again, both of these services are at no charge to Mr. Anderson.

Mr. Anderson has allowed our dumpster to be placed and the first dumpster was filled and is being switched out this morning.

Mr. Anderson has removed his RV, Volkswagen, van, boat, antique car...they have all been removed from his driveway.

The service providers have been made aware of Mr. Anderson's deadline of 7-29-16, unfortunately, the refrigerator and water heater are pending the contractors evaluation of whether they can get the work done in that environment.
