Dear Property Representative:

Your building was re-inspected for the Fire Certificate of Occupancy on June 10, 2015. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected immediately.

A reinspection will be made on July 15, 2015 at 9:30am.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

- 1. EXTERIOR SPLC 34.08 (7) All parking spaces shall be paved with asphalt, concrete, or durable dustless surfacing. Before any existing spaces may be paved, site plan approval must be obtained as specified in the St. Paul Zoning Code. Contact DSI Zoning at 651-266-9090. -Existing Class V driveway has not been maintained. Vehicles are parking throughout the rear yard on muddy and grassy areas.
- 2. UNIT 2 MSFC 1028.3 Remove the materials that cause an exit obstruction. Maintain a clear and unobstructed exitway. -Remove the items blocking the bedroom egress windows.
- 3. UNIT 2 MSFC 315.2 Provide and maintain orderly storage of materials.

- 4. UNIT 2 MN Stat. 299F.362 Immediately provide and maintain a smoke detector located outside each sleeping area. -Occupant admitted to tampering/damaging smoke detector in the hallway outside the bedrooms causing it to be inoperable. Property owner replaced detector during inspection. Advise occupant if smoke detector is found to be disabled or tampered with again, a criminal citation will be issued.
- 5. UNIT 4 SPLC 34.23, MSFC 110.1 This occupancy is condemned as unsafe or dangerous. This occupancy must not be used until re-inspected and approved by this office. -Unit 4 is condemned due to extensive fire damage and cannot be reoccupied until inspected and approved under permit. Contact DSI at 651-266-8989.
- 6. SPLC 34.11 (6), 34.34 (3) Provide service of heating facility by a licensed contractor which must include a carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office.-Have the permit for the new boiler installation finaled and approved.
- 7. SPLC 39.02(c) Complete and sign the smoke detector affidavit and return it to this office.

You have the right to appeal these orders to the Legislative Hearing Officer.
