Subject: Update on Furnace Repairs

Dear Marsha,

I hope this message finds you well. I apologize for not sending this information (see attached) with Amber earlier, but I wanted to ensure you received it directly. I obtained a copy of the relevant documentation today and can provide all the part receipts if needed.

As you may know, we had three different companies assess our furnace, all of whom recommended a complete replacement rather than repairs. This included the last company that Georgia mentioned. Fortunately, I consulted with a realtor friend who recommended Tony. He came out to evaluate the situation and thoroughly reviewed the furnace's operation.

Tony identified that the "air safety switch" was malfunctioning and promptly replaced it. After this repair, the furnace began functioning correctly. We had previously replaced most components ourselves, but this particular issue had eluded us.

I would like to bring to your attention several pressing issues regarding the property in question, as we aim to establish a safe and clean environment for its residents.

Firstly, we have made significant progress by installing a working washer and dryer, sealing broken windows, and replacing a leaking water meter. Additionally, I plan to ensure that the water heater operates more effectively by the coming weekend. However, I must express my ongoing concerns regarding the overall cleanliness of the home. Although considerable cleaning has been undertaken, I do not believe the residence is currently suitable for habitation.

To address our immediate needs, I recommend placing a dumpster in front of the house; unfortunately, Waste Management has declined this request. Moreover, we require assistance in setting up an Amber CAD waiver to facilitate the hiring of a professional cleaning company to adequately address the sanitation of the property.

It is also essential to replace various damaged walls, particularly those affected by children's actions, and restore four windows that have been broken. Much of this work could potentially be funded through energy assistance programs, and I would appreciate it if the task of completing the necessary application could be added to Amber's list of responsibilities.

I want to highlight that Amber may not yet recognize that the safety and cleanliness standards of the house are presently inadequate. Therefore, I recommend limiting the residency of individuals in the home to those listed on the energy assistance application to maintain better oversight.

Lastly, I urge coordination with animal control for the removal of any animals currently living on the property. These animals require veterinary care, which Amber cannot afford. If possible, it would be beneficial to include a provision that prohibits her from owning pets while residing at the property.

Thank you for your attention to these matters. I look forward to working collaboratively to ensure the property meets acceptable standards for safety and cleanliness.
