On 08/24/2024 at approximately 0243 hours, I, Officer A. Martell (224) was dispatched to 170 10th St E (Liquor Vault) to a motion alarm. Once on scene, a broken window was located on the West side of the business. It did not appear as though an individual could fit through the hole in the window. There was a liquor barrel sitting next to the window with bottles of liquor sitting on top. The bottles of liquor were well within reach for someone to reach in the window and take them. It is believed that an unknown number of bottles of liquor were stolen from the business. There was at least one bottle that was broken on the floor, along with a neon sign.

A keyholder for the business was not able to be contacted. Board up crew was contacted. They came out to the scene and boarded up the broken window. A business card with a case number was left inside the window of the business for staff when they open in the morning.

I took photos of the damage and uploaded them to Axon Capture.

No suspect information is available at this time.

Narrative :

I, Data Release Specialist Arlene Krueger am currently assigned to the Video Management Unit, a division of the Technology Unit. I am also a LEVA Certified Forensic Video Technician.

Part of my duties include being asked to assist investigators in locating and exporting surveillance video, Saint Paul Police Department Closed-Circuit Television (CCTV) footage, Saint Paul Police Department Squad In Car Camera (ICC) footage, and Saint Paul Police Department Officer Body Worn Camera (BWC) footage.

Regarding this case, I received a Forensic Video Collection request from Sergeant Heather Weyker of the Central Investigations Unit to collect video from the Liquor Vault located at 170 10th St E.

On 8/28/2024 I drove to this location spoke with on-shift employees who gave me verbal permission to search/export video from the Alibi NVR. This NVR can be identified using model number ALI-NVR5116P and serial number 1620151203BBRR559396546WCVU.

When comparing the date/time stamp of the live video display to the date/time stamp on my department issued iPhone, I noted the time was 7 minutes 12 seconds fast (DVR 8/28/2024 11:53:49; Cell 8/28/2024 11:46:37). The time difference was calculated using the DVR Time Calc app located on my iPhone.

I exported video from all cameras using the default MP4 file format, date of 8/24/2024 and the time frame of 02:40 (actual 02:33) through 03:00 (actual 02:53) to a USB flash drive that I had with me.

When the export process was complete, I used my department issued laptop computer to verify I could playback the video data using the included media player.

Upon return to SPPD HQ, I used the computer program Zimmerman Hasher to generate a HASH report in MD5 and SHA-256 for the files on the flash drive.

I burned all the data from the flash drive to a Blu-ray disc and entered the disc into property. I left a copy of the disc on Sergeant Weyker's desk.
