Hi Brian,

Your next Legislative Hearing in our office (if you haven't received your Code Compliance cert) isn't until August 25. You can keep working and pulling permits until then. At that point a couple weeks before you'll receive a letter (via email) from Mai Vang in our office asking you to reach out to Inspector Zane for a progress inspection at which time he'll give a percentage to Legislative Hearing staff. If you aren't done you'll likely need to just do an updated work plan and resubmit proof of financing (unless you're very close to complete). If you are past 50% at that point your Performance Deposit will be continued, otherwise there will be a discussion about that as well.

Progress is continuing on our 925 Magnolia rehabilitation.

We are about a month behind schedule, and it is apparent we will need the 6 month extension.

Money and skill here is fine, by family has been in and out of the hospital in Florida- (dad is 86) and I have had to fly down 4 times.

Anyways,

The interior paint will be finished up in a day or two. All drywall/mud complete. New cabinets 80% installed.

The Electricians will then come out for their final outlet installations and such, in mid July.

The flooring, trim, and plumbing fixtures will be ongoing, and will be completed a couple months beyond the original 180 days-depending on their schedules.
