**For more than three years, the vacant CVS at Snelling & University has stood as a symbol of neglect in our neighborhood.**

***Now, the City is moving forward with hearings that will decide its future — and we need your voice at the table.***

Since its closure on Friday April 1st 2022, the CVS property has generated more than 100 complaints for trash, vandalism, drug use, thousands of discarded sharps/foils, and break-ins.

**This building, in its current state, is unsafe, unsightly, and unfit for our neighborhood.**

It diminishes the aesthetics of the Snelling–University intersection, erodes community pride, and undermines the sense of safety and

dignity neighbors deserve to feel in Hamline Midway.

Neighbors and HMC have pushed for accountability every step of the way — from petitions and public meetings, to direct advocacy with the Department of Safety & Inspections (DSI).

**This summer, DSI declared the property a nuisance site, subject to demolition if conditions aren't corrected.**

That means the upcoming Legislative Hearing (Sept. 30, 9:00 AM) and City Council Hearing (Nov. 5, 3:30 PM) will determine whether this corner remains a monument to neglect — or becomes the start of something brand new for Hamline Midway.

HMC is urging the City to demolish this property as it longer serves our neighbors, our neighborhood's ten-year plan, or the broader city.

**We're asking all of our neighbors to take action by submitting public comments to amplify the voice of the neighborhood. Your testimony becomes part of the official public record, and every voice matters.**

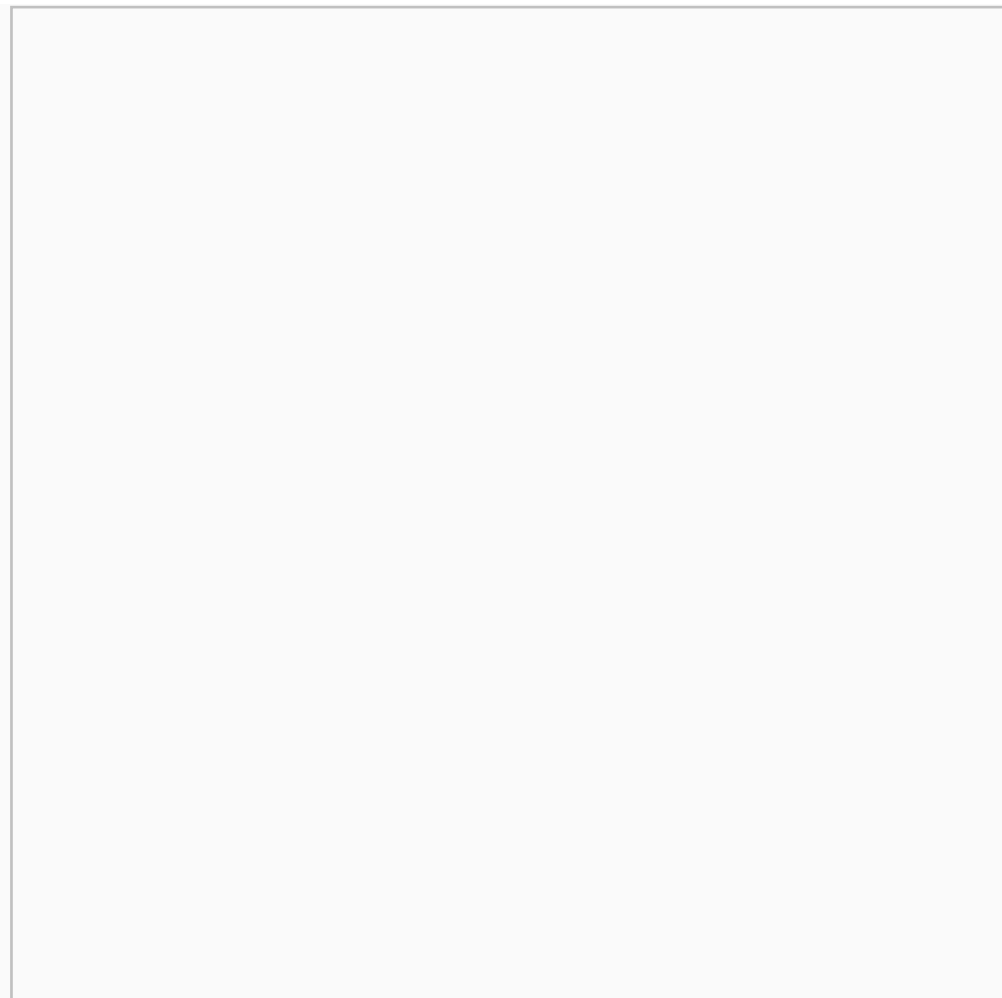
**That work has now grown into a new partnership: the Snelling & University Alliance — co-founded by the Hamline Midway Coalition, Union Park District Council, the Midway Chamber of Commerce, and African Economic Development Solutions.**

The Alliance brings stakeholders together across the borders of organizations, jurisdictions, wards, and neighborhoods.

- **The mission** is to help make connections and work collaboratively to support the commercial and residential areas surrounding the intersection of Snelling Ave and University Ave in Saint Paul.

With support from a Ramsey County planning grant, the Alliance is creating a Cohesive Vision Plan to revitalize Snelling & University — centering equity, accountability, sustainability, and community voice.

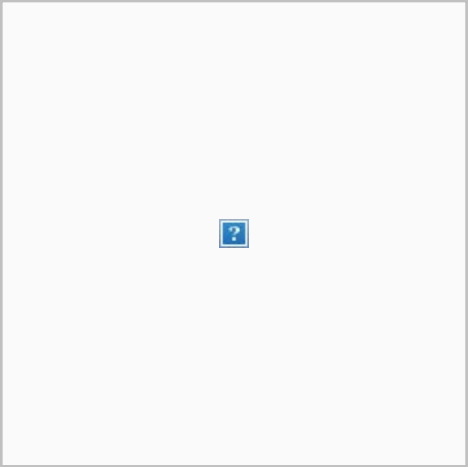
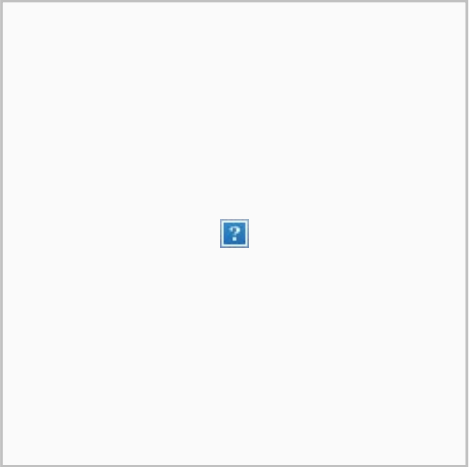
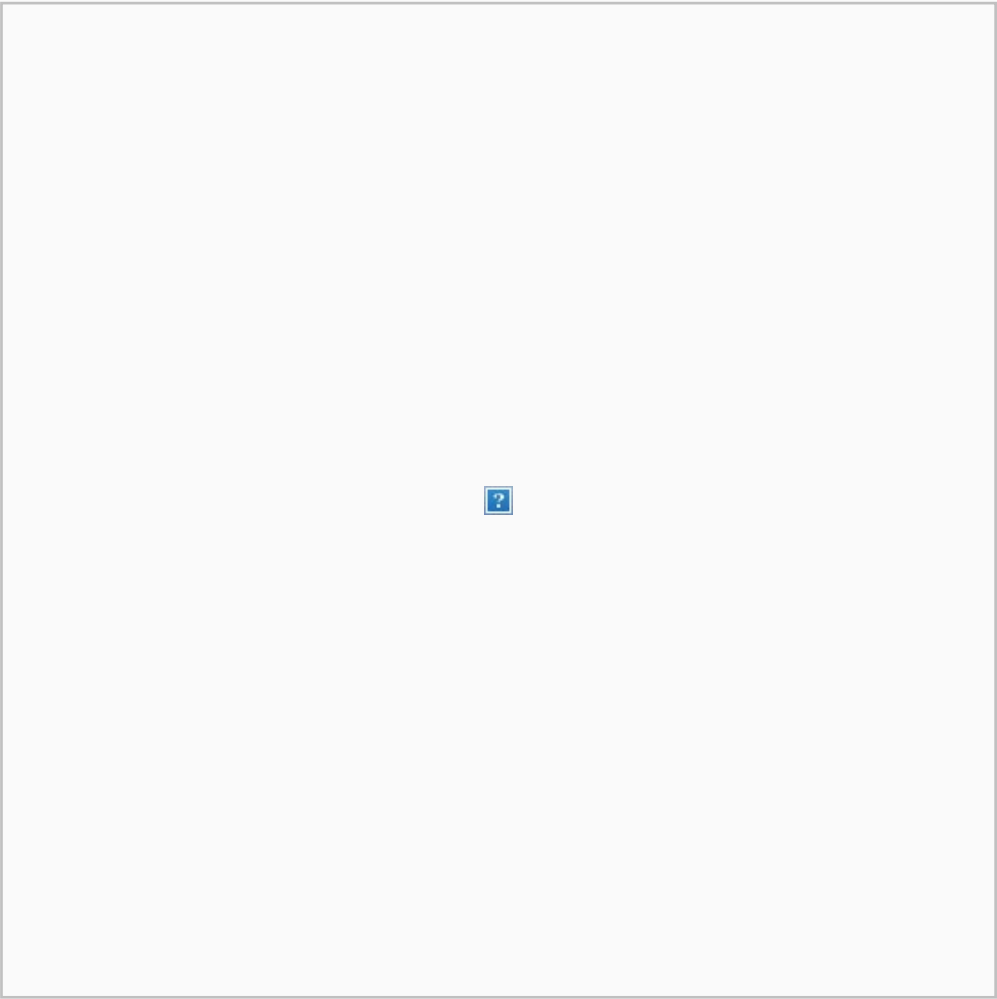
While we work together to take action on the CVS site, let's also celebrate the new and longstanding businesses that make this neighborhood strong.
